N. Tirupati (25) S/o Nagarajan is No. 171, Harijan Colony, Subramaniapuram, Madurai- 625 011 He lives at . He belongs to the Scheduled Caste community. He also works as a COVID-19 prevention worker at the Rajaji Government Hospital in Madurai and earns a living from the family's earnings.

Ibid. N. Tirupati (25) S/o There are no criminal cases against Nagarajan. In this case, the last 08.02.2021 It was Monday N. Tirupati (25) S/o Nagarajan and his cousin Kaleeswaran, Friends Isakki, He went to Pandikoil with Palani for a relative's earring ceremony and went to the temple in the evening. 4.00 Around 1 p.m. TN-58 Q 2178 They were coming home in an Indica car. That car N.Tirupati (25) S/o Nagarajan's friend Palani was driving. At that time, Madurai Subramaniapuram Gurukulam was coming near the school. N.Tirupati (25) S/o Four policemen from Jaihindpuram police station, who already identified Nagarajan, blocked him. Two of them were in police uniform and two were in plain clothes other than police uniforms. One of the policemen looked at the occupants of the car, Where are you going? he asked. They said they were going to an earring ceremony at a relative's house. One of the policemen said, "All of you should come to the police station and you have to be taken there for questioning." Then N.Tirupati (25) S/o Nagarajan said, "I have seen you before and we have not done anything wrong, why are you calling the police station?" Each of them said, We know who you are! They brought us to the Jaihindupuram police station with their cars and motorcycles and talked to Sub-Inspector Selvakumar about something. Sub Inspector Selvakumar N.Tirupati (25) S/o Looking at Nagarajan, Which area do you have?? He asked. Sir, they said that our house is in Subramaniapuram colony. You are all colonists, I was expecting you,

he laughed. Seeing this, N.Tirupati (25) S/o Nagarajan asked if the colony meant Nakkala sir. Sub-Inspector Selvakumar is a resident of the colony, Don't you talk against me; Talk obscenely about Devudiya Payale N.Tirupati (25) S/o He hit Nagarajan with his right hand alternately on both the sides. He also punched her in the face with her hand. He kicked his boots and knocked them down. At that time, the other policemen who were with him also beat Tirupathi with lathis in their hands and tortured him alternately. And the above lying down N.Tirupati (25) S/o Nagarajan is back to the colonial dog, son of Devadiya, Speak your mouth, They beat him alternately with lathis, his legs, buttocks and back, asking him if he would question the police. Unable to bear the beating, he cried in agony. Cops hit the ear, Blood was oozing from his nose and mouth. He is also in pain. At that time, the said Tirupati S/P. Two of the three men who came with Nagarajan slapped Palanikumar and Isaki and chased them home. Then further N.Tirupati S/o Kaleeswaran, the cousin of Nagarajan, was also beaten up. then N.Tirupati S/o Separation on Nagarajan and his brother Kaleeswaran 75 They have filed a case in the United States and told me not to tell anyone what happened here. besides N.Tirupati S/o Nagarajan had Rs 1 lakh in his pocket. 500 They have stolen money. Those who have already been beaten out by the police N.Tirupati S/o Nagarajan's cousin Valavanraj 7.00 They came to the Jaihindpuram police station around the clock and spoke to the police and took the victims to their homes. He was bleeding from his mouth and nose after returning home. So N.Tirupati (25) S/o Nagarajan's wife Tamilselvi, His relatives including his sister Valarmathi inquired about the incident., He was an in-patient at the Government Rajaji Hospital, Madurai. 11.38 They have been admitted for treatment. Doctors asked for the incident and asked the accident register number Sl. No. A. 1936483 They registered and informed the police. Police 08.02.2021 That night, that is. 09.02.2021 morning 3.00 Around the hour N.Tirupati S/o They took a statement from Nagarajan. Since then, no case has been registered against the policemen who have been tortured and tortured and no further action has been taken. Doctors have taken X-rays and scans and are continuing treatment. More Doctors Tirupati S/o Nagarajan has suffered a fractured jaw.

Four persons, including Kaleeswaran, Palani and Isaki, were direct chats for the incident. The police team led by Jaihindupuram sub-inspector Selvakumar illegally arrested and tortured her in custody and tortured her in the CCTV camera installed at the police station.

Therefore, N. Tirupathi (25) S/o who is not involved in any crime. We request you to register a legal case against the four policemen who illegally arrested and detained Nagarajan and his relatives and tortured them with lathis and shoe.
